1. Mode of Payment will be ON LINE through SBI Collect (<https://www.onlinesbi.com/prelogin/icollecthome.htm>).
2. Payment may be made through Credit Card / Debit card / E-Banking as per the convenience.
3. For DASA students, Hostel fee - SBI Collect but Institute fee through SWIFT only
4. Part payment will not be accepted.
5. Payment should be made by i-collect through internet banking only.
6. Education loans - NEFT by lending banks (please submit proof with UTR No to the administrative office).
7. Students who are applying for Bank Loan / Scholarship should pay the Institute fees at the stipulated time. The bank loan / Scholarship amount, subsequently received from Bank / State / Central Governments will be transferred to the students account.

8. Excess payment will neither be reimbursed nor be adjusted. The concerned student / parent will be responsible for any excess payment.
9. Payment made by NEFT / RTGS for students who are not availing education loan will be treated as due against the student. The students have to pay the fee again through SBI Collect.
10. Cash / Demand Draft / Cheque/ Pay Orders, etc are NOT ACCEPTED.
11. **Last date of payment without fine 02.01.2017.**
12. **With fine of Rs.500/- from 03.01.2017 to 09.01.2017.**
13. **10.01.2017 onwards the students have to pay readmission fee of Rs.1,000/- + fine of Rs.500/- with the permission of the Registrar (i/c). The payment without permission of the Registrar (i/c) will be treated as due.**
14. **Those who fail to pay the fees on or before 09.01.2017 will not be allowed to attend classes from 10.01.2017 and not allowed to stay in the hostel.**
15. The hostellers are instructed to submit the payment proof of hostel fee to the hostel warden for room allotment. If failed, the room will not be allocated to the students.
16. All the students are instructed to submit the proof of payment (except SBI Collect) to the administrative office.
