Number of Posts: 1(One)

Essential Qualification: MBBS Degree or equivalent qualification included in any one of the Schedules of the Indian Medical Council Act 1956 (102 of 1956) and must be registered in a state Medical Council or Indian Medical Council.

Age Limit: Not exceeding 65 years

Terms and Conditions:

1. The appointment is purely on temporary basis. The job is initially for a period of 6 months and further extension is based on performance every 6 months up to a maximum of 3 years.
2. Medical Officer is expected to work in shift duties including holidays and should be willing to do afternoon and night shifts.

General Instructions:

1. Prescribed application form and other details may be downloaded from Institute's website.
2. The post is purely on temporary basis and this post does not confer any right to claim either for subsequent employment or permanent post in future.
3. Candidates should submit self-attested photo copies of required certificates and other documents, in support of their claims in the applications such as age, community (in the prescribed format), educational qualifications, experience etc., along with the application form. Applications not fulfilling the above or applications received through email will not be considered.
4. The candidates applying for the post should ensure that they fulfill all the eligibility conditions. Their admission to any stage of the selection process will be purely provisional subject to satisfying the eligibility conditions.

5. The prescribed essential qualifications / experience indicated are bare minimum and mere possession of the same will not entitle the candidate to be called for Interview.
6. The Institute reserves the right to restrict the number of candidates called for interview to a reasonable limit on the basis of qualifications, level of relevance experience and other academic achievements.
7. The Institute has the right to decide the mode of screening and testing the applicant for short listing and selection.
